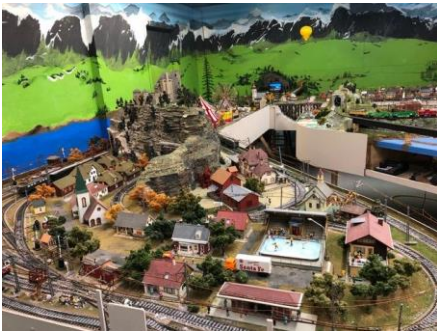
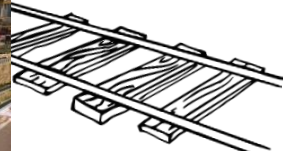

Bob Isermann asked the Board of Directors (BOD) for direction on handling the increase of requests for charity donations. A procedure was needed for how much money the club should retain in reserve as well as a process for handling requests.

- The BOD provided the following direction related to budget reserve for the club
 - Club keeps \$100 per member in the budget reserve (Example: 100 members x \$100 = \$10,000)
 - Anything above this amount would be eligible for charitable contributions

- The statues of the club's permanent charity, "USO of Missouri" stays the same as it is today
- The BOD provided the following direction related to current and future charity requests
 - All requests for charities will be put in writing and given to Howard for review
 - On a quarterly basis, the club will vote on the charities and amount to be given
 - If a charity is not approved in any quarterly vote, it may be carried over and voted on in the next quarter
- All future requests for Charity evaluations are to be directed to Howard Sardis
 - guidelines for necessary information required will be made available
 - Howard will review requests
 - if Howard feels the request and charity are viable, he will bring to the club to present
 - Howard will bring the next group for consideration in April 2019
- Discussion
 - Chris Reitz stated that in the NCCC as their Treasurer, their practice is to have a full year of expenses as a minimum of budget reserve (excludes charitable donations)
- Bob asked for an opinion survey from the group on if the BOD has the authority to make these recommendations

The cost of the banquet is \$35.00 per person and includes a full 4 course family style dinner plus open bar until 10:30 pm.

The next governors' meetings are Friday evening, February 22nd and Saturday, February 23rd. Contact Tom R. if interested in attending. The Regional meeting starts Saturday morning at 8:30 am, the National meeting begins Saturday at 12:30 pm. Our own Chris Reitz was elected National Treasurer for NCCC and took office January 1st of this year.

AUTOCROSS

Our date is **June 29 and 30, 2019** The Family Arena fees are going up again this year up \$400 from last year. I have a budget to get approved for the event tonight, Expenses are: awards (T-shirts), timing services, miscellaneous supplies, lot rental and 4 sanctions from STL Corvette Club, totaling of \$4,300. The anticipated income is \$5,380 for a net profit of \$1,080. This does NOT include food sales which would be another \$300-\$400 and is based on 40 entrants. Last year we had 38 which is our lowest year ever. Our past 10 year average including last year is 48. Therefore, 40 entrants is a conservative estimate.

To our valued USO of Missouri supporters,

On behalf of the Board of Directors of the USO of Missouri, we wanted to provide our valued donors with a brief update on the "OneUSO" initiative undertaken by our parent organization, USO, Inc. **While OneUSO has been formally adopted by USO, Inc, it will not at this time materially change the way USO of Missouri is managed nor how we deliver services to our troops.** Here is a brief summary of OneUSO.

Essentially, the OneUSO initiative will unify all USO activities under a single management and fiduciary structure, based at USO, Inc. in Arlington, VA. However, through a year-long process of communication, education and negotiation, the USO, Inc Board of Governors approved a OneUSO "phased" model that will allow USO Chartered Centers, such as the USO of Missouri, to maintain local management and fiduciary autonomy. We believe this is a win-win for USO, Inc and the USO of Missouri primarily because USO, Inc will begin their multi-year OneUSO transformation to improve service delivery in non-served areas of the United States while **USO of Missouri will continue to control locally all of our service, administration and fundraising activities.** A great outcome but there remains a separate and very important distinction on fundraising that needs to be amplified as we move forward.

USO, Inc and USO of Missouri currently and continuing through 2023 will remain two independently operated 501(c)(3) charitable organizations. Donations to USO, Inc will not be distributed to USO of Missouri. Donations to USO of Missouri will stay with USO of Missouri and be invested locally to serve active duty military members and their families. This critical distinction is not only important as it relates to where the donations are invested but also how they are strategically managed. What happens after 2023 is unknown.

From management and fiduciary perspectives, at a strategic level, Charity Navigator (www.charitynavigator.org) has awarded USO of Missouri a 96.83 overall score. From a ground-level, tactical viewpoint, here are a few key hallmarks of the USO of Missouri program, that we believe give us competitive advantage as a stand-alone organization.

- A 37-year history of an expanding portfolio of services and service delivery innovations
- A unique Therapy Dog program for service members and their families.
- 2 mobile operations units
- Satellite facility on-post at Fort Leonard Wood

Dear Bob,

One of the best parts of my job is being able to share success stories with the people who make them possible. Today, I am writing to you to thank you for being that person.

You may have read about Elizabeth in some of our newsletters or through our social media posts. Born premature and with mild cerebral palsy, Elizabeth spent the first five years of her life moving around by using the "military crawl" - pulling herself around using her forearms. Her Aunt Patty knew she needed to find someone who could help Elizabeth but the small rural town in Kansas where she lived had limited medical resources.

Then she learned about Wings of Hope.

We have been flying Elizabeth the 1,100 mile roundtrip from her home in Kansas to St. Louis for surgery and ongoing treatment since May of 2017 and her progress has been remarkable. In fact, Aunt Patty calls it "a miracle."

Elizabeth has gone from crawling on her forearms, to walking with a walker, to climbing stairs. At Elizabeth's last doctors' appointment she was walking so fast we could hardly keep up with her. Her doctors anticipate she will be out of the walker and using crutches by beginning of 2019. I look forward to sending you *that* update!

It may only look like words on a page, but thank you. Thank you for making a difference in not only this little girl's life, but in the lives of hundreds of children we serve. None of it would have been possible without you and others who believe in the power of giving.
